



TK TYPE End User License Agreement (EULA) VERSION 1.0, FEBRUARY 2010

This is an End User License Agreement (EULA) between you (the End User) and TK TYPE. Please read this Agreement carefully. By downloading and/or installing TK TYPE Font Software, you are agreeing to the terms of this license.

The purchase of 1 TK TYPE license grants up to 5 users, of a single organization, the right to use a copy of the Font Software. Copies may be made for archival purposes. This software is copyrighted and contains intellectual property information protected by law. You are not allowed to reproduce, sell, transfer, license, give away or otherwise distribute the Font Software in any form.

MULTI-USERS LICENSE AGREEMENT

If more than 5 users will be using the Font Software, you are required to purchase a multi-users license using the following table as a reference.

1-5 USERS:	1 LICENSE
6-10 USERS:	2 LICENSES
11-25 USERS:	3 LICENSES
26-50 USERS:	4 LICENSES
51+ USERS:	5 LICENSES

You may provide the font to a graphic designer, printer or other service bureau that is working on your behalf only if they agree to use the font exclusively for your work, agree to the terms of this license, and retain no copies of the font on completion of the work.
